Minutes: The motion was made, seconded and unanimous vote to waive the reading and accept the minutes for the 5/14/2024 meeting as previously emailed to all officers and board of directors.

President’s Report: Dave reported an update on the shotgun range. We have received a request for funding from Central Valley Regional Water Quality Control Board. According to Lee Smith, our legal counsel, this is new but not unexpected. Due to California budget constraints, this bureaucracy is charging for this oversight of our range.

I will be asking the board’s approval to sign the CVRWQCB’s Acknowledgment of Receipt of Oversight Cost Reimbursement Account Letter. This document is holding up their report to Central Unified Program Agencies. The motion was made, seconded and unanimous vote for Dave Longcor, President, to sign the Acknowledgement and return to CVRWQCB and commitment to \$3680.00 for cleanup oversight.

I talked with Lee Smith and shared my building frustration and the fact of our diminishing funds. We agreed that it is time to stop being timid with the county and start pushing them. We need to be more aggressive before they bleed us dry. Upon return of the Acknowledgment, I will request a prompt response to El Dorado Gun Club and El Dorado County. Lee Smith will be contacting the county to suggest “that we have jumped through all of your hoops”. As soon the county receives this report, please let’s move on and come to a decision.

Vice President & Senior Range Manager Report (SRM): Bob reported that the lower range is running well. The El Dorado County Sheriff’s Department has taken extra days but that has not impacted the fees collected.

Secretary’s Report: No report. A big thank you to Sandra for taking the minutes while I was out-of-town.
